Must be at least 18 years of age to join.
- SENIOR MEMBERSHIP: **\$85.00 per year**. You will receive full membership rights and privileges including gate access, full range access, membership card, button and voting privilege. This membership includes you and your immediate family (spouse and dependent children **20** and under). Only the primary member whose name is on the membership roster may vote. Must be age **65** or over (I.D. Required).
